MODE OF MEETING

1. The 33rd AGM of the Company will be conducted fully virtual through live streaming and online remote voting using the Remote Participation and Voting (“**RPV**”) facilities provided by Tricor Investor & Issuing House Services Sdn Bhd (“**Tricor**”) in Malaysia via its TIIH Online website at <https://tiih.online>.
2. According to the Revised Guidance Note and FAQs, an online meeting platform can be recognised as the meeting venue or place under Section 327(2) of Companies Act 2016 provided that the online platform is located in Malaysia, provided that the online platform located in Malaysia.
3. Kindly check the Company’s website or announcements for the latest updates on the status of the 33rd AGM.

RPV FACILITIES

1. Shareholders are able to attend virtually, speak (in the form of real time submission of typed texts) and vote (collectively, “**participate**”) remotely at the 33rd AGM using the RPV provided by Tricor via its TIIH Online website at <https://tiih.online>. Please refer to the Procedure for RPV contained herein for more information.
2. A shareholder who has appointed a proxy(ies) or authorised representative(s) or attorney(s) to participate at the 33rd AGM via the RPV must request his/her proxy(ies) or authorised representative(s) or attorney(s) to register himself/herself for RPV at the TIIH Online website at <https://tiih.online>. Please refer to the Procedure for RPV contained herein for more information.

PROCEDURES FOR RPV

Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) who wish to participate in the 33rd AGM will need to follow the requirements and procedures as summarised below:

(a)	Sign-up as a user with TIIH Online	<ul style="list-style-type: none"> Using your computer, access the TIIH Online website at https://tiih.online. Sign-up as a user under "e-Services", select "Create Account by Individual Holder". Refer to the tutorial guide posted on the homepage for assistance. User registration will be approved within one (1) working day and you will be notified via email. If you are already a user with TIIH Online, you are not required to sign-up again. You will receive an email to notify you that remote participation is available for registration at TIIH Online.
(b)	Submit your registration for RPV	<ul style="list-style-type: none"> Registration is open from Tuesday, 30 April 2024 until the day of the 33rd AGM on Tuesday, 11 June 2024. Shareholder(s)/proxy(ies)/attorney(s)/corporate representative(s) are required to pre-register their attendance for the 33rd AGM to ascertain their eligibility to participate at the 33rd AGM using the RPV. Login with your user ID (i.e: email address) and password and select the corporate event: "(REGISTRATION) PERAK CORPORATION BERHAD 33RD AGM". Read and agree to the Terms & Conditions and confirm the Declaration. Select "Register for Remote Participation and Voting". Review your registration and proceed to register. The system will send an email to notify you that your registration for remote participation is received and will be verified. After verification of your registration against the General Meeting Record of Depositors dated 5 June 2024, the system will send you an email after 9 June 2024 to approve or reject your registration for remote participation. <p><i>(Note: Please allow sufficient time for approval of new user of TIIH Online and registration for the RPV).</i></p>

(c)	Login to TIIH Online	<ul style="list-style-type: none"> Login with your user ID and password for remote participation at the 33rd AGM at any time from 9.00 a.m. i.e. 1 hour before the commencement of meeting on Tuesday, 11 June 2024 at 10.00 a.m.
(d)	Participate through Live Streaming	<ul style="list-style-type: none"> Select the corporate event: "(LIVE STREAM MEETING) PERAK CORPORATION BERHAD 33RD AGM" to engage in the proceedings of the 33rd AGM remotely. If you have any question for the Chairman/Board, you may use the query box to transmit your question. The Chairman/ Board will endeavor to respond to questions submitted by you during the 33rd AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.

(e)	Online Remote Voting	<ul style="list-style-type: none"> • Voting session commences from 10.00 a.m. on Tuesday, 11 June 2024 until a time when the Chairman announces the end of the session. • Select the corporate event: "(REMOTE VOTING) PERAK CORPORATION BERHAD 33RD AGM" or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box. • Read and agree to the Terms & Conditions and confirm the Declaration. • Select the CDS account that represents your shareholdings. • Indicate your votes for the resolutions that are tabled for voting. • Confirm and submit your votes.
(f)	End of remote participation	<ul style="list-style-type: none"> • The live streaming will end upon the announcement by the Chairman on the conclusion of the 33rd AGM.

1.1 NOTE TO USERS OF THE RPV FACILITIES:

1. Should your registration for the RPV facilities be approved, we will make available to you the right to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

RECORD OF DEPOSITORS

The date of Record of Depositors for the 33rd AGM is Wednesday, 5 June 2024. As such, only members whose name appears in the Record of Depositors as at Wednesday, 5 June 2024 shall be entitled to attend the 33rd AGM and to participate, speak and vote thereat.

1.2 ENTITLEMENT TO PARTICIPATE AND APPOINTMENT OF PROXY

Only members whose name appear on the Record of Depositors as at Wednesday, 5 June 2024 shall be eligible to attend, speak and vote at the 33rd AGM or appoint proxy(ies) and/ or the Chairman of the Meeting to attend and vote on his/ her behalf.

In view that the 33rd AGM will be conducted on a virtual basis, a member can appoint the Chairman of the Meeting as his/ her proxy and indicate the voting instruction in the Proxy Form.

If you wish to participate in the 33rd AGM yourself, please do not submit any Proxy Form for the 33rd AGM. You will not be allowed to participate in the 33rd AGM together with a proxy appointed by you.

Accordingly, proxy forms and/ or documents relating to the appointment of proxy/corporate representative/attorney for the 33rd AGM whether in a hard copy form or by electronic means shall be deposited or submitted in the following manner not later than **Sunday, 9 June 2024 at 10.00 a.m.:**

Proceed with submission of Proxy Form	<ul style="list-style-type: none">After the release of the Notice of Meeting by the Company, login with your user ID (i.e. email address) and password.Select the corporate event: "PERAK CORPORATION BERHAD 33RD AGM – SUBMISSION OF PROXY FORM".Read and agree to the Terms & Conditions and confirm the Declaration.Insert your CDS account number and indicate the number of shares for your proxy(ies) to vote on your behalf.Appoint your proxy(ies) and insert the required details of your proxy(ies) or appoint Chairman as your proxy.Indicate your voting instructions – FOR or AGAINST, otherwise your proxy(ies) will decide your votes.Review and confirm your proxy(s) appointment.Print proxy form for your record.

Register as a User With TIIH Online	<ul style="list-style-type: none">Access TIIH Online at https://tiih.online.Under the "e-Services", the authorised or nominated representative of the corporate or institutional shareholder selects the "Sign Up" button and followed by "Create Account by Representative of Corporate Holder".Complete the registration form and upload the required documents.Registration will be verified, and you will be notified by email within one to two (2) working days.Proceed to activate your account with the temporary password given in the email and re-set your own password. <p><i>(Note: The representative of a corporate or institutional shareholder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact Tricor Investor & Issuing House Services Sdn Bhd if you need clarifications on the user registration.)</i></p>
